



Voice Actor Generative AI Agreement

1. This Agreement (the Voice Actor Generative AI Agreement) between _____ [Voice Actor] and _____ [Other Party] dated _____ [date] supersedes any conflicting arrangement. It expressly prevents _____ [Other Party] from using or authorising the use of: _____ [Voice Actor's] voice or any element thereof, performance or any element thereof, and likeness in any way not explicitly authorised by _____ [Voice Actor] in relation to generative Artificial Intelligence (AI) input, systems and/or outputs for the purposes of training large language models or creating voice clones, digital avatars, or synthetic voice doubles.
2. The Voice Actor Generative AI Agreement is to be read as an attachment to the Agreement between _____ [Voice Actor] and _____ [Other Party] dated _____ [date] (the Agreement). _____ [Other Party] is only entitled to use _____ [Voice Actor's] performance for any purpose agreed to by both parties in writing and only those agreed purposes.
3. _____ [Voice Actor] warrants that the voice used in the relevant performance and provided via recording or any other means to _____ [Other Party] is their own.
4. _____ [Other Party] warrants that their use of the voice used in performance and provided by _____ [Voice Actor] is limited to the Agreement for which it was provided. Specifically, _____ [Other Party] agrees not to:
 - a. Use any part of _____ [Voice Actor's] voice, file, recording, performance or likeness of _____ [Voice Actor's] voice, file, recording or performance beyond that specified in the Agreement;
 - b. Use any of _____ [Voice Actor's] voice, file, recording, or performance to simulate or generate any 'soundalike', similar or identical voice or likeness of _____ [Voice Actor's] voice, file, recording, or performance;
 - c. Provide to any third party any part of _____ [Voice Actor's] voice, file, recording, or performance;

- d. License, sell or transfer ownership of all or any part or aspect of any of the original files capturing any part of the recording of the performance to any third party without the explicit, written permission of _____ [Voice Actor];
- e. Enter into any arrangements purporting to be on behalf of or with the endorsement of _____ [Voice Actor]; and
- f. Enter into any agreements to use any part of _____ [Voice Actor's] voice, file, recording, or performance to be used for AI including, but not limited to text to speech, or speech to speech without _____ [Voice Actor's] knowledge and consent.
5. _____ [Other Party] will use good faith efforts to prevent any part of _____ [Voice Actor's] voice, file, recording, or performance to be accessed by unauthorised parties, including, but not limited to ensuring the content is stored safely with necessary safeguards to prevent unauthorised access.
6. If any cloned or similar sounding 'voice' comes to their attention, _____ [Other Party] undertakes to alert _____ [Voice Actor] immediately or as soon as is possible thereafter.
